1. Introduction:

B.Sc. Aviation or Bachelor of Science (Aviation) is a bachelor's degree that deals with the science of Aviation. Aviation Science, as the name suggests, refers to the study, design and operation of aircraft. It is also necessary for aircraft maintenance and air traffic control. The science of aviation includes all the support systems that keep air traffic safe, efficient and orderly, including traffic control, arrival operations, air traffic control, maintenance and the pilot.

This booklet gives information about the Admission Procedure and Admission Test (PI) for **Bachelor of Science (Aviation)**

2. Programme & Intake:

The total duration for a full-time program is four years which divides into 8 semesters

Program	Mumbai Campus
Bachelor of Science (Aviation)	60

The total duration for a full-time program is four years which divides into 8 semesters with multiple exit option as per NEP 2020 guidelines.

Candidates who have admitted for the program, the 1st year of the program will be completed in Mumbai Campus and the 2nd year onwards will be conducted at Shirpur Campus.

Exit option after first year - Students will be awarded Under Graduate Certificate (Aviation) after successfully completing all requirements as per curriculum

Exist option after second year- Students will be awarded Diploma in Aviation after successfully completing all requirements as per curriculum

Exist option after third year- Bachelor of Science (Aviation) Degree will be awarded after completion. all requirements as per curriculum

On completion of fourth year Honours degree will be awarded

3. Eligibility criteria for admission (Fulfilling all / applicable conditions mandatory)

- Students who wish to pursue this program must have passed 10+2 with 50% aggregate (or equivalent level examination) from a recognized board with Physics and Mathematics as core subjects

Or

- Students who have completed diploma with 50% aggregate. They must have studied physics and mathematics during diploma are also eligible to apply for the program.

- Students who already hold an Indian Commercial Pilot License (CPL) or Air Transport Pilot License (ATPL) can be admitted directly into second year of program.

For candidate of International Baccalaureate

- A) The candidate of International Baccalaureate Diploma (IB certificate / & D.P (Diploma awarded) candidates from International Baccalaureate (IB) Board are considered to 10+2 or equivalence examination with 24 grades/credits compulsory and has passed 3 subjects at Higher Level (HL) and 3 subjects at Standard Level (SL) plus extended essay and TOK and should have obtained a minimum of 50% aggregate marks.
- B) DP course candidates from International Baccalaureate (IB) Boards are considered to 10 +2 or equivalence examination with 2 subjects at Higher Level (HL) and 2 subjects at Standard Level (SL) OR 3 subjects at Standard Level (SL) and 1 subject at Higher Level (HL) and should have obtained a minimum of 50% aggregate marks.
- C) IBCP equivalence for General Strand (Arts, Commerce, Science, Law): CP course candidates from International Baccalaureate (IB) Board are considered 2 DP subjects with at least 1 subjects at Higher Level (HL) and minimum 3 points in each DP subject along with Career related studies with at least 03 subjects offered by IB and should have obtained a minimum of 50% aggregate marks.
- D) IBCP equivalence for Engineering or Medicine Strand: CP course candidates from International Baccalaureate (IB) Board are considered 3 DP subjects (Maths, Physics, Chemistry, Biology or other similar subjects) with at least 1 subjects at Higher Level (HL) and minimum 03 points in each DP subject along with Career related studies with at least 03 subjects offered by IB. Further eligibility criteria as stipulated by statutory bodies like AICTE and should have obtained a minimum of 50% aggregate marks.

- **For IB & Cambridge Candidate:**

Candidates who are called for admission on the basis of merit list & if they do not have their 10+2 or equivalent examination mark sheets, will be given “Provisional Admission” based on predicted scores. Fees will be accepted from such candidate but their admission will be confirmed only after the submission of the final mark sheet before the commencement of the program if found eligible. Mark sheet/Transcripts issued by Board/University/school will only be considered.

- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their (10+2) examination from Overseas Universities.
- Those candidates who have passed, or, are appearing for 10+2 examination from a Board/University where Grade Point Average is given, such candidates must produce in writing from the Board/University concerned, the equivalent percentage for the GPA /CGPA obtained.

- Candidate whose final mark sheet is not available at the time of admission is required to upload internet copy/ DG Locker of result duly attested by Principal of the school / college, failing which candidate will not be admitted for the program.
- Only single mark sheet from single board with all compulsory subjects taken / opted and passed will be considered. Compartmentalized mark sheet will not be considered.
- Candidate will not be eligible if any subject is marked as ungraded/fail in mark sheet/grade sheet. For absent/ungraded in any of the additional/non mandatory subject will be consider as eligible provided such candidate is declared as pass by respective board.
- Candidates appearing for their final 10+2 or equivalent examination can also apply provided they must obtain the required minimum cut off marks and also produce the entire necessary Documents, in original, within the given stipulated time
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clauses.

4. **Admission Process:**

Online Registration & Payment of Registration Fee:

- Visit www.nmims.edu for online registration.
- Pay registration fee of **Rs.2000/- (Non – refundable)**. Please refer online registration for payment details.
- Before filling the online form, please read all the instructions carefully mentioned in the admission information handout and important dates.
- Registration Fee is non-refundable/ non-transferable.

5. **Selection Process -**

Merit List will be on the basis of Personal Interview.

6. **Program fees: (subject to change): for information**

- Program fees for the **1st Year** (batch 2024) was Rs.1,00,000/- p.a. & Fees for Flying hours and hostel at Shirpur: **49.0 Lacs** + 2.0 Lacs for hostel
- Fees for batch 2025 will be informed at the time of admission

7. **Important Instructions:**

- Candidates will be offered Programme based on the availability of seat, candidates merit rank.
- The XII examination should have been conducted before the course commencement date.
- Mark sheet/Transcripts issued by Board/University only be considered (School/Institute will not be accepted).
- For cancellation/ withdrawal of admission: Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate has to upload cancellation

form duly filled and signed, fees paid receipt copy & cancelled cheque (personal account) to mentioned link : <https://upload.nmims.edu/admission/cancellation/>

- Canvassing in any form for admission will disqualify the candidature.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- Please see the important dates and preserve it as a guide. All announcements from the institute will be through its web site: www.nmims.edu and no individual communication will be sent to the candidates. Kindly check website regularly for any updates.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clauses.
- Candidate's uploaded documents will be verified online & if found not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses.
- It is the sole responsibility of the candidates to ascertain whether they possess the necessary and requisite qualification for the admission to the courses at NMIMS.
- Admission to program is considered as "Provisional Admission" till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program.
